David Hawkins

Director, Climate Programs
Natural Resources Defense Council

David Hawkins is the director of NRDC's climate center. He joined NRDC as an attorney in 1971 and worked on air pollution issues until 1977, when he was appointed assistant administrator for Air, Noise and Radiation at the Environmental Protection Agency during the Carter administration. David returned to NRDC in 1981 and worked throughout the next decade primarily on reauthorizing the Clean Air Act. David was the director of NRDC's air and energy program from 1990 to 2001, until he became director of the newly-created climate center. David is a recognized expert on advanced coal technologies and carbon capture and storage, and is working with Congress to design a legislative mechanism to reduce global warming emissions. David has an English degree from Yale College and a law degree from Columbia University.

John C. McClure

Vice President & General Counsel

Nebraska Public Power District

John McClure is Vice President and General Counsel for Nebraska Public Power District. He joined Nebraska Public Power District in 1980 following graduation from the University of Nebraska College of Law, and spent his first 13 years in the General Counsel's office. In 1993, John was asked by NPPD's CEO to lead the utility's strategic planning. He held several other senior management positions over the next 10 years involving industry deregulation, governmental affairs, corporate communications, and environmental and water issues. In 2004, he was selected by NPPD's Board of Directors to become General Counsel. He is currently responsible for legal, governmental, environmental, water resource, and corporate communication functions at NPPD.

Sarah Dempsey

Vice President of Educational Services

Northeast Community College

Sarah Dempsey has been Vice President of Educational Services at Northeast Community College for the past two and a half years. She has held administrative positions at community colleges in four states over the past 25 years. She currently serves as Chair of the Chief Instructional Officers Council for Nebraska community colleges, co-chair of the Nebraska Ethanol Training Advisory Board, and is the lead administrator for a \$2 million statewide ethanol production training project funded by the Department of Labor.

Her campus has become a leader in Nebraska for providing renewable energy programs, the newest being a \$100,000 grant for wind energy training funded by the Walmart Workforce Economic Initiative. One of only 20 grants in the country funded by this initiative, this project will develop curriculum to support Nebraska's expanding interests in providing alternative energy sources to reduce the nation's reliance on foreign oil imports.
